American Fire Culture Past, Present & Future

The American fire culture has been a manual fire protection model based on six underlying assumptions or DNA genes: fast, close, wet, risk, injury and death. To survive in the 21st century, fire service leadership must change our cultural paradigm to automatic fire protection that does not accept fire loss. This session will help you develop strategies to address key issues in reducing the number of firefighter and civilian fire deaths. This workshop is based on two books: Organizational Culture and Leadership. Edgar H. Schein, Jossey Bass Publishing, 2010 and I can't Save You, But I'll Die Trying: The American Fire culture. Burton A. Clark, Premium Press America, 2015. Participants will develop strategies to change the American fire culture at the individual, team, organizational, and community levels in an effort to reduce loss from fire through literature review, lecture/discussion, case study, critical thinking, and group activity.

First Responder Safety/Investigative Considerations for the Illegal Manufacture of Butane Hash Oil and Marijuana Grow Operations

In Nov. 2012, voters approved and added to the Colorado Constitution a law legalizing the use and possession of limited amounts of marijuana for anyone ages 21 or older. Colorado provided a system of regulating retail marijuana, including licensure of facilities for cultivation, manufacturing, testing and retail stores. As a result, the Colorado municipalities created a process to permit and oversee retail marijuana establishments beginning in 2014. Twenty-six states currently have laws legalizing marijuana in some form. Inspection of Marijuana Related Occupancies is for anyone tasked with inspecting these new businesses in order to better understand and prepare for the unique challenges these occupancies present to the fire service.

From Tones to Extinguishment

Fireground safety through standardization

This class will explore the concept and tactics of the combat ready mind set. Are we ready for what faces us on the fire ground? Have we prepared our equipment and crew to operate safely? Do we know building construction and how it affects our strategies and tactics; residential vs. commercial? The importance of command presence and the initial 5 minutes of an incident sets the tone. Is the first arriving crew completing a 360 and doing a scene size-up from the ground up: initial water application; the most water in the fastest way; hand lines (1 3/4" vs 2 1/2") or deck gun; tactics deployed; offensive, defensive, or transitional attack; fire ground communications; consideration of standardized radio model so everyone is on the same page.

Is your department on the path to a LODD? This compelling presentation by the National Fallen Firefighters Foundation examines the root causes of LODDs and the role of Leadership, Accountability, Culture and Knowledge (LACK) as it influences the end result. Size-up and Command for a Small Department: How to Avoid Being Lost in the Fog of the Fireground

My mistakes of getting "sidetracked" on arrival could have led to a serious problem on one of my fireground commands. Don't let yourself be sidetracked at your next serious event. While not a military veteran, I have tons of respect for and consider myself an avid reader and student of military leadership and command. A book from a former Marine who fought in World War II describes the term "lost in the fog of war." According to this author, this expression describes both the literal fog created by the dust, smoke, and debris of the battlefield and, more importantly, the mental fog of confusion and uncertainty created by lack of knowledge of the enemy. I share this experience as an example for others with the intent of helping current and future officers not make my mistake of getting "lost." Attendees will review the critical points of size-up and past events where the 'fog" was thick and leave with a better understanding and a better "vision" that will enable them to see through the fog of the fireground, creating a more effective and safer environment for those under their command.

Stress First Aid (SFA) for Firefighters and Emergency Services Personnel

Stress First Aid (SFA) is a flexible set of tools used to care for stress reactions in firefighters and rescue personnel. Unlike other acute stress management procedures, SFA was designed specifically to support firefighters and rescue personnel. The goal of SFA is to restore health and readiness after a stress reaction. SFA is a toolkit that emphasizes the importance of continuously monitoring the stress of fire and rescue personnel and to quickly recognize and appropriately help individuals who are reacting to stress and are in need of interventions to promote healing. SFA monitors the progress of recovery to ensure a return to full-function. SFA fosters strong leadership and unit cohesion. SFA is individualized to meet the needs of each person in each context; there are no one-size-fits-all SFA solutions.

Best, Rick - Rick Best has 22 years in the fire service where he started out as a volunteer firefighter and worked his way into a full-time position for the City of Westerville (Ohio) Division of Fire. He also serves as a Fire Training Officer II for the Ohio Fire Academy, a division of the State Fire Marshal's Office. Currently, Rick holds the position of Eastern Division Advocate Manager for the National Fallen Firefighters, Everyone Goes Home® Program (EGH) where he is one of the primary trainers, delivering programs across the nation to develop instructors for our Courage to Be Safe (CTBS) and Leadership, Accountability, Culture, and Knowledge (LACK) courses.



Briggs, Mark – Mark Briggs began his fire career in 1980 with Rossford Fire Department. He was with Rossford for 25 years. During that time, he received his 240-hour Professional Fire Fighter and paramedic certifications. Mark was promoted to the positions of lieutenant and captain which included departmental training. He also worked as a paramedic for Mobile Medic Ambulance service and was assigned to Lake Townshipp Fire Departments Medic 50 as the Primary ALS unit. In 2002, Mark began working for Village Ottawa Hills Fire Department. In 2011, the Toledo Fire and Rescue Department took over fire service for the village and Mark continued with TFRD.
