# **Fatal Occupational Injuries in 2016**

The <u>Bureau of Labor Statistics</u> reported that a total of 5,190 fatal work injuries occurred in the U.S. in 2016. That's a 7-percent increase from 2015. It's the first time more than 5,000 fatalities happened since 2008. The fatal injury rate increased to 3.6 per 100,000 full-time equivalent workers from 3.4 in 2015. That's the highest rate since 2010. In Ohio, the fatality rate went down 18 percent, and the injury rate declined from 3.9 to 3.1.

# **Firefighter Fatalities**

The U.S. Fire Administration issued a report on <u>Firefighter Fatalities in the United States in 2016</u>. Eighty-nine firefighters died while on duty in 2016. That's one less than the 2015 total of 90, and five fewer than the 94 firefighter fatalities in 2014.
