

Ohio Department of Public Safety

[Ohio Revised Code Chapter 4765](#): Laws governing EMS providers, firefighters, fire safety inspectors, instructors, chartered fire training institutions, accredited and approved EMS training institutions, EMS and research grants, and Ohio's trauma system.

[Ohio Revised Code Chapter 4766](#): Laws governing licensure of medical transportation organizations, including providers of emergency medical services, inter-facility ground transportation via ambulance and mobile intensive care unit, air medical services and wheelchair transportation services (ambulettes).

[Ohio Administrative Code 5765](#): Administrative rules pertaining to EMS provider certification and renewal and continuing education, accredited and approved training institutions, instructors, curriculum, Regional Physician Advisory Board (RPAB), trauma, data and grants can be found in Ohio Administrative Code 4765 (4765-1 to 4765-10 and 4765-12 to 4765-19). Rules pertaining to firefighter and fire safety inspector certification and renewal, fire charters and instructors.

[Ohio Administrative Code 4766](#): Administrative rules pertaining to the Ohio Medical Transportation Board. Includes rules on the certification and licensure of ambulances, mobile intensive care units, ambulettes and air medical services.
